In case of change in the fee structure the school shall inform to the appropriate authority in the month of January for the next academic year and will also issue printed receipt of fees/funds to the students.

- 14. In addition to above the Managing Committee shall abide by the provisions of Haryana School Education Rules, 2003 and amendments if any thereafter. The Managing Committee shall be liable for disciplinary action in case of violation of any provisions of the rules.
- 15 school will provide ramp within six months otherwise recognition will stands withdrawn
- 16. If any information, at any stage found Contrary to the Fact's the recognition would be revoked forthwith
- 17 That the number of students in classroom shall not be more than the students calculated on the square feet per student for secondary and Senior Secondary Schools and 9 Square feet per student for elementary state.
